How Long is the Data Kept

CamObs collects very limited data about any of its users. CamObs only collects as little data as is necessary to provide the Service and the data is only retained as long as is necessary to provide and improve the Service, to allow us to comply with our legal obligations, and to provide the products, content, or services requested.

How is the Data Used

The data entered into CamObs is never sold or rented to anyone. All information that may be collected by CamObs will be used to deliver and improve the Service while you use the Service. Information collected by CamObs can be entered manually by the user or may be collected automatically by the Service. The CamObs website service is intended only for use by adults 18 years or older.

We use the personal data we collect to communicate with you, deliver what is requested, improve the Service, to present offers related to your interests, for security purposes, as required by law, and/or to enforce our Terms.
